

### 608 Compliance

EPA Section 608 establishes critical guidelines for refrigerant management, covering record-keeping, leak rate assessments, repair timelines, and equipment retirement. Compliance is crucial, with penalties as high as \$335,000 for failing to repair leaks, highlighting the importance of proactive processes and technology in place to meet these regulations.

### AIM Act and focus on Part III

Under the Technology Transition Rule, compliance mandates now require the adoption of Automatic Leak Detection Systems (ALDs) for specific new and used appliances. This reflects a pivotal shift towards advanced technologies, emphasizing that food retailers embrace innovation and proactively meet sustainability objectives and regulatory requirements.






